

REACH STATEMENT

Dear Valued Customer,

REACH is a European Community Regulation on chemicals and their safe use (EU Regulation No. 1907/2006). It deals with the Registration, Evaluation, Authorization, and Restriction of Chemical substances.

The Swissbit AG (Swissbit) supports the aim of REACH in improving the protection of human health and the environment through the better and earlier identification of the intrinsic properties of chemical substances. Swissbit meets all applicable REACH requirements and is committed to provide our customers with information about substances in its products as required.

Under REACH, the registration provision is applicable to manufacturers or importers of chemicals and does not apply to Swissbit's manufacturing operations. As referred to in the REACH regulations Swissbit is a downstream user, so it is anticipated that substances used in electronic products will be registered by the raw material manufacturers within the supply chain. To further ensure compliance, Swissbit continually reviews information from its suppliers about delivered material and products concerning substances which are contained on the European Chemical Agency (ECHA) Candidate List of Substances of Very High Concern (SVHC).

Swissbit's products are "articles" as defined in within by REACH and do not contain any Candidate List SVHC in excess of the 0.1% concentration by weight limit. Furthermore, based on both material content declarations from our suppliers and independent laboratory testing none of the Candidate List substances (including all **84 substances till 2012-06-18**) also no Diphenylether-Pentabromderivat and Perfluorooctansulfonat – PFOS (EU Regulation No. 207/2011 / EU Regulation No. 1907/2006, annex XVII) are present in Swissbit products.
